PROGRAM BACKGROUND

The RWJBarnabas Health (RWJBH) Institute for Prevention and Recovery (IFPR) Peer Recovery Program (PRP) provides in-person and virtual recovery support services for individuals with substance use disorder. PRP employs Recovery Specialists who are in recovery from substance use disorder and provide consultation and peer recovery support as well as clinically trained Patient Navigators who link individuals to appropriate levels of care. 1

PRP, formerly known as the Opioid Overdose Recovery Program (OORP), serves patients 24 hours a day, 7 days a week, in hospitals throughout Essex, Hudson, Middlesex, Monmouth, Ocean, Somerset, and Union counties. In addition to serving emergency department patients who received naloxone to reverse an opioid overdose, PRP also serves patients with substance use disorder in emergency departments of all participating hospitals, inpatient units of RWJBH hospitals, and outpatient settings. 
REPORT OVERVIEW

In 2023, Recovery Specialists received referrals during 18,478 patient encounters. During 4,170 follow-up calls conducted one year postconsultation, 137 patients reported being in recovery, representing 3% of eligible patients and 70% of patients who were successfully contacted.

The 2023 Annual Report presents information on referrals, the population served, and program outcomes, as well as staff and program updates and a summary of the RWJBH ED buprenorphine induction initiative (see pages 5-8). The Appendix contains data stratified by location. The information included in this report is preliminary and subject to change.

REFERRAL SUMMARY

Recovery Specialists received 18,478 referrals in 2023. There were 18,130 referrals in 2022, 16,244 referrals in 2021, 18,475 referrals in 2020, 18,585 referrals in 2019, 9,060 referrals in 2018, 1,898 referrals in 2017, and 720 referrals in 2016. STAFF UPDATES

Assistant Director, PRP

On October 16, 2023, Paris Branda was named Assistant Director for the Peer Recovery Program. In his new role, Paris will oversee all hospital-based PRP services.

Paris started with IFPR in 2018 as a Patient Navigator before being promoted to Patient Navigator Supervisor and then PRP Manager. Most recently, Paris has combined his clinical and non-clinical experience to lead our patient navigation, case management, and community-based recovery support teams.

Paris not only brings a wealth of knowledge and experience in the area of substance use disorder but also has a demonstrated ability of balanced and strategic leadership, which further supports IFPR's strategic plan and core values. Paris will help ensure PRP continues to enhance the patient-centered, whole-person, harm reduction-focused services we offer to countless patients across RWJBH.

Manager, PRP

In 2023 Quarter 4, **Kate Beam was named Manager for the Peer Recovery Program.** In her new role, Kate will oversee all hospital-based PRP services at RWJ University Hospital Hamilton and RWJ University Hospital Somerset. Kate started in 2018 as a Recovery Specialist at RWJ University Hospital Somerset and was recently a PRP Supervisor at Jersey City Medical Center.

In 2023 Quarter 4, **Shalanda Tudor was named the new Manager for the Community-Based Peer Recovery Program.** In her new role, Shalanda will oversee all community-based recovery support and case management services. Shalanda started in 2018 as a Patient Navigator and was recently a Patient Navigator Supervisor.

PROGRAM UPDATES



On November 25, 2023, IFPR marked the 100,000th patient referral to the Peer Recovery Program. PRP's 100,000-patient-referral milestone demonstrates IFPR's ability to provide patient-centered, whole-person services to patients across the state.

In December 2023, Ruth Palacio, Clinical Health Educator, completed and obtained the authorized status of Recovery Coach Professional Facilitator Designation. This new designation, along with her CCAR Training of Trainers certification, will allow Ruth to continue providing CCAR trainings for Recovery Specialists, ensuring the highest standards and best practices are in place.

In December 2023, Rafael Domingues, Director of Security Administration, developed and held weekly trainings specific to peer support work focusing on verbal de-escalation skills and basic defense skills. He incorporated real life examples submitted by our teams as the practice scenarios. All Recovery Specialists will attend this training.

In 2023, IFPR's maternal health program welcomed six new babies! The expansion into women's health allowed IFPR to hire two doulacertified maternal health specialists to serve RWJBH patients and the Middlesex County community. As we transition into the second year of this program, our focus will be on hosting community events, diaper drives, and other resource fairs with our partners.

ED MOUD QUALITY METRIC

In 2023 Quarter 2, RWJBH facilities adopted an incentivized ED quality metric attributed to buprenorphine induction for naloxone-reversed patients in the ED. Patients are excluded from the metric if they have been admitted to the hospital after being treated in the ED, if they are unavailable for services (e.g., PESS), or they were inappropriately referred to PRP (e.g., received naloxone as a precaution). In 2023, **35.1% of patients were administered or prescribed buprenorphine, which surpassed the goal of 25%.**





Since the inception of the ED MOUD quality metric, the proportion of patients administered or prescribed buprenorphine post-naloxone reversal has continued to trend upwards.




Buprenorphine administrations and prescriptions have increased for non-naloxone-reversed patients as well as patients included in the ED MOUD quality metric.





REFERRAL SUMMARY


Fewer than one in ten referred patients received at least one dose of naloxone prior to consultation. More than three-quarters of referrals were placed in the emergency department; the remainder were placed in inpatient units and outpatient settings. Referrals by day of the week and time of day are shown below.

Throughout this report, "Unknown" consists of responses of "Do not know" or "Refused" and missing data. Additional data is available in the Appendix.












POPULATION SERVED


Of the 18,478 referred patients, approximately two-thirds were male. Most patients were between the ages of 26-44 (41.2%) and 45-64 (40.6%). Approximately four in ten (42.0%) patients were white, 29.8% were Black, and 19.5% were Hispanic/Latino. The majority of patients were covered by Medicaid (42.5%) or were uninsured (14.2%), 12.2% were homeless, and 35.8% did not have access to transportation.









POPULATION SERVED (CONTINUED)











PROGRAM OUTCOMES

To measure success, the Institute for Prevention and Recovery utilizes the Substance Abuse and Mental Health Services Administration's (SAMHSA's) working definition of recovery, which emphasizes the process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential.² Four major dimensions—health, home, purpose, and community—support recovery. PRP assists in the process of recovery by providing recovery support services and clinical referrals.

In 2023, 66 patients were not available for consultation (e.g., left against medical advice, were unresponsive, were deceased). 92.5% of patients available for consultation accepted consultation by a Recovery Specialist. 83.8% of patients who accepted consultation also accepted some form of support services.








PROGRAM OUTCOMES (CONTINUED)

In 2023, patients accepted 1,334 referrals to levels of care offered by Patient Navigators, including 770 referrals to withdrawal management and 65 referrals for medications for opioid use disorder. Accepted and offered referrals are included in the Appendix.




Recovery Specialists follow up with patients for a minimum of eight weeks postconsultation. In 2023, PRP staff conducted 127,964 instances of follow-up, including 13,602 face-to-face contacts. Patient Navigators were responsible for approximately one-tenth of all instances of follow-up.



PROGRAM OUTCOMES (CONTINUED)

PRP staff follow up with patients 3, 6, 9, and 12 months post-consultation to assess long-term recovery. In 2023, PRP staff attempted 22,781 of these follow-up calls, and 1,227 patients were successfully contacted. Of patients contacted one year post-consultation, 137 reported currently being in recovery, representing 3.3% of eligible patients and 70.3% of patients who were successfully contacted.






CLINICAL SUPPORT SUPERVISION

IFPR supports and encourages workforce development for individuals in recovery. To ensure that all PRP Recovery Specialists are National Certified Peer Recovery Support Specialists (NCPRSS) and the best that they can be, IFPR offers support and guidance through Clinical Support Supervision (CSS). Ten Supervisors offer a minimum of one individual and one group supervision session per month to each Recovery Specialist. Supervisors complete the Certified Clinical Support Training offered by the New Jersey Prevention Network (NJPN).

Though separate, CSS works in conjunction with administrative supervision offered by PRP Managers. CSS focuses on the Code of Ethics (NAADAC) and Core Competencies (SAMHSA); professional goals; self-care practices and compassion fatigue awareness; enhancing peer support work and strengthening skills; boundaries; identifying role difference, role drift, and scope of peer work; and teamwork skills.

In 2023, Clinical Support Supervisors held 856 individual sessions and 90 group sessions averaging six attendees per session.





In 2023, Clinical Support Supervisors and Recovery Specialists **discussed ethical conduct in approximately half of CSS sessions and the Recovery Specialist- patient relationship in more than three-quarters of CSS sessions.** The most frequently discussed Core Competencies were provides support, shares lived experience of recovery, engages peers in collaborative and caring relationships, and personalizes peer support.




NALOXONE DISTRIBUTION

PRP partners with RWJBarnabas Health's Corporate Pharmacy Division and the Rutgers Opioid Overdose Prevention Network (OOPN) to distribute naloxone. In 2023, **Recovery Specialists distributed 676 naloxone kits to patients.** The majority of these kits were dispensed to patients in Hudson County (33.1%) and Essex County (20.4%). Jersey City Medical Center distributed the most kits (224).


